- Introductions each committee member introduced themselves and spoke about their particular interest in housing issues. The issues included:
 - Workforce housing (mentioned x4)
 - Housing for clients
 - o Housing for homeless individuals and families
 - Affordable housing (mentioned x4)
 - Rural housing
- Organizational structure
 - We need a team leader this will be Elizabeth. She will organize the meetings [she will send out a Doodle poll for the next 3 meetings]; send out minutes; prepare agendas; secure the meeting room; assign a facilitator (or be the facilitator).
 - We need someone to take minutes we agreed that we will rotate this responsibility among LJO, Carla, Lara, Linda and Lisa.
 - Support for the committee's work comes from Thais, the project manager for **Healthy Mendocino**. Also, we can look to <u>www.healthymendocino.org</u> for resources and in the future our team's minutes, et al. will be posted there, as are all the other teams.
 - Thais provided some background. A community health needs assessment was done as the preliminary work for Healthy Mendocino with the interviewing of community members to get their perspectives on the five main topics that HM will be tackling: poverty, mental health, family wellness, childhood trauma and housing. Teams have been established in Ukiah and now the regional teams are being set up.
 - There will be a summit in October to share ideas with all the teams.
 - The Ukiah housing team has been meeting for about a year and has 30-40 members.
 - We need to figure out who we are, what stand(s) we will take;
 what type of campaign do we want to launch
- Letting the community know about this work and hopefully involving other interested folks:
 - Need to do publicity and community education
 - Movie night
 - An article in the paper
 - talk to Kate Lee, the publisher of the Advocate; have columns in the paper

- Radio program. e.g, Angela De Witt in Anderson Valley Housing Assn has a radio program
- Could have an interview on KZYX w Richard Miller
- Prepare educational material for people to learning about housing issues
- Possibly make an inventory of all the issues, of the 'system' of housing, do a map
- Other discussion points mentioned in the meeting:
 - We need to work on messaging
 - The topic of housing is of interest to both city and county folks.
 We need to make ourselves a "hot" item, with solid ideas and suggestions and get them interested in participating. We can come up with ideas, choices, group of concepts to present
 - Could we invite a staff person from Marie Jones' office (e.g., Sarah)?
 - Other stakeholders:
 - Mendocino college
 - Rich makes the point that people need to feel safe, to be able to get a job
 - Affordable housing what is the definition? How does the county define affordable housing?
 - We need to look at regional solutions
 - o Funding has to be built into what we do
 - We discussed that there is an effort to get the TOT money from campgrounds.
 - Discussion about taxes from cannabis
 - Discussion about vacation rentals, paying for business licenses.
 Could take the TOT money from vacation rentals that might then discourage some people to rent
 - Suggestion an affordable housing subsidy for helping people who need a little extra for rent or to help build a house
 - The county is working on putting a cap on the Airbnb's.
